KNOW ALL MEN BY THESE PRESENTS, That in consideration of Five Thousand Dollars and other valuable considerations to the undersigned grantor Earsell C. Roberts in hand paid by R.J. Barnett the receipt whereof is acknowledged we the said Earsell C. Roberts and wife, Addie Belle Roberts do grant, bargain, sell and convey unto the said R.J. Barnett the following described real estate, situated in Shelby County, Alabama, to-wit:

The Southeast Quarter of Southeast quarter ( $SE\frac{1}{4}$  of  $SE\frac{1}{4}$ ) and the Southwest Diagonal Half of the Northeast quarter of the southeast quarter ( $NE\frac{1}{4}$  of  $SE\frac{1}{4}$ ) Section One (1), and the Northeast quarter of Northeast quarter ( $NE\frac{1}{4}$  of  $NE\frac{1}{4}$ ) of Section Twelve (12), Township Twenty-two (22), Range Three (3) West; and also all of the southwest quarter of southwest quarter ( $SW\frac{1}{4}$  of  $SW\frac{1}{4}$ ), Section Six (6), Township twenty-two (22), Range Two (2) West, except that part conveyed to Josuah M. Frost, by deed recorded in Volume 27, page 147 of the Records in the Probate Office of Shelby County, Alabama; less all easements and rights of way as of record.

The Grantee assumes and agrees to pay that certain mortgage dated August 12, 1947 to Myrtle H. Wilson, and recorded in Mortgage Book Volume 201, at page 202, in the Office of the Judge of Probate of Shelby County, Alabama, balance of said indebtedness warranted to be \$14,874.84 as of this date.

The grantee assumes and agrees to pay the taxes for the current 1950 tax year ending September 30, 1950.

TO HAVE AND TO HOLD to the said R.J. Barnett, his heirs and assigns forever.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said R.J. Barnett, his heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances; except as specifically set out herein; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said R.J. Barnett, his heirs, and assigns forever against the lawful claims of all persons.
