Before me, M.B. Chappell, a Notary Public, in and for said County, in said State, this day came Effie Dunnam Jones, who, being first duly sworn, deposes and says as follows:

My names is Effie Dunname Jones. I am years old, and reside in Jefferson County, Alabama, My father was James M. Dunnam , now deceased. He died prior to the 28th day of May, 1938, and said date the following were his only surviving children and heirs at law, viz: Valeria Dunnam Jones, whose husband was W.E. Jones, Leonard Dunnam, whose wife was Ida Mae Dunnam, Delila Dunnam Scott, whose husband was B.D. Scott, Andrew Dunnam, whose wife was Minnie Dunnam, James Dunnam, whose wife was Annie Dunnam, Charlie Dunnam, whose wife was Ruth Dunnam, and Affiant, Effie Dunnam Jones, whose husband was F.W. Jones. When my said father died, He was the owner in possession of the following described lands in Shelby County, Alabama:

' Beginning at the center of the west line of section ten (10), township twenty-two (22) range three (3) west, and run thence north, along the section line, 1694 feet, to the point of beginning; thence, east and parallel to the east and west center line of said section, 1840 feet, more or less, to the west edge of a mill pond; thence, northerly, along the west edge of said mill pond, to the north line of said section, thence, westward, along said section line, to the northwest corner of said section 10; thence, south along the west boundary of said section, 933.5 feet, to the point of beginning, containing 38 acres, more or less.

' Also a part of the northwest quarter (NW $\frac{1}{4}$ of the southeast quarter (SE $\frac{1}{4}$) of section nine (9), township twenty-two (22), range three (3) west, described as follows: 'Beginning at a point 1750 feet west of the center of the east line of said section, and run south 659 feet, to the east and west center line of the north half of the southeast quarter (N $\frac{1}{2}$ of SE $\frac{1}{4}$) of said section; thence west, along said section line, 875 feet, to the north and south center line of said section; thence north 660 feet, to the center line of said section; thence east 875 feet, to the point of beginning, containing 13 1/3 acres, more or less, ' to the point of beginning, 'Excepting from the above a roadway 30 feet wide on the west side of the property described in section ten (10) and a roadway 30 feet wide along the south side of the property described in section nine (9) '.

' My said father, James M. Dunnam obtained title to said lands by deed from Columbus F. Dunnam and wife, Maggie A. Dunnam, and Annie Mae Dunname, an unmarried woman, and by descent, in the year 1913, and went into possession, at said time, Since said time, the said James M. Dunnam and his heirs at law, and their grantess, have been in continuous, uninterrupted, peaceable, and hostile possession of said lands, claiming the same against all others. At no time, during said period, has either J.M. Poole or Mrs. Rebecca J. Pool been in possession of any part of said lands, nor have either of them claimed to own any interest in said lands, to the best of my knowledge and belief. "
