Begin on the south line of the SE<sup>1</sup>/<sub>4</sub> of SE<sup>1</sup>/<sub>4</sub> of Section 14, Township 20, Range 3 West, at a point where the same crosses the east line of the Atlantic Coast Line Railroad right of way and run north, 89 degrees 30 minutes east, along the south line of said forty acres and along the south line of SW<sup>1</sup>/<sub>4</sub> of Sw<sup>1</sup>/<sub>4</sub> of Section 13, Township 20, Range 3 West, a distance of 307.9 feet to the southwest corner of a lot being conveyed to Ernest Alfred Cooper; thence north, 13 degrees 45 minutes west and along the west line of said Cooper lot 106 feet; thence south, 89 degrees 30 minutes west, 332.9 feet, more or less to the east right of way line of Atlantic Coast Line Railroad; thence along same south, 28 degrees 50 minutes east. 141.2 feet to the point of beginning; being situated in Shelby County, Alabama.

Hilyer his heirs and assigns, forever, against the lawful claims of all persons.
