KNOW ALL MEN BY THESE PRESENTS, That I, W.G. Parker , a widower, for and in consideration of Eight Hundred (\$800.00) Dollars to me paid in hand by H.L. Gould the receipt whereof is hereby acknowledged, do grant, bargain, sell and convey unto the said H.L. Gould the following described property, to-wit:

One house & lot on the North side of the land going through by Will Hester's to the street going by the school property up to J.B. Turner's and more particularly described as follows:

Commencing at North east corner of Jone's lot and the North west corner of the old Bird Teague lot where the two intersects with W.G. Parker's land, thence running North with a wire fence Three Hundred Fifteen (315) feet to Lauderdale's land, thence East with Lauderdale's line to Jno. McGiboney's line and continuing East with McGiboney's line Three Hundred Fifteen (315) feet to an iron stob, thence South Three Hundred Fifteen (315) feet to the land herebefore mentioned, thence West with said land to the point of beginning; containing Two and one Half ( $2\frac{1}{2}$ ) acres, more or less; being the home where H.L. Gould now lives, situated , lying and being in the County of Shelby and State of Alabama.

TO HAVE AND TO HOLD the same unto the said H.L. Gould his heirs and assigns, forever. And I do for myself and my heirs, executors, and administrators, covenant with the said H.L. Gould, his heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all incumbrances; that I have a good right to sell and convey the said property ; that I will, and my heirs, executors , and administrators, shall warrant and defend the same to the said H.L. Gould, his heirs, executors, and assigns, forever, against the lawful claims of all persons whomsoever.
