Dorough, receipt of which is hereby acknowledged, we the said J.F. Butler and wife Vassie V. Butler, do remise, release, relinquish, quitclaim and convey unto the said Jesse E. Dorough, the following described land situated in Shelby County, Alabama, to-wit:

A part of the Southwest Quarter of the Southeast Quarter of Section 29, Township 20, South, Range 2 East, described as follows: Beginning at the intersection of the South boundary of the right of way of State Highway No. 25 and the center line of a road leading South from said Highway to Jesse E. Dorough's residence; run thence in a southerly direction along the center line of said private road 315 feet; run thence in an easterly direction and parallel with State Highway No. 25, 1106 feet 4 inches; turn an angle of 90° to the left and run 315 feet, more or less to the south side of right of way of State Highway No. 25; run thence in a westerly direction along the South boundary of said Highway to point of beginning, containing 8 acres, more or less, being bounded on the North by State Highway No. 25, and on the West by said private road.
