Affiant further saysthat of his own personal knowledge, he knows that the Shelby Fron Company of Alabama took possession of the lots or parcels of land described above and held the open, notorious, continuous, peaceable and adverse possession of said lands, claiming the same as its own against all the world, and regularly and continuously assessed and paid taxes thereon until said tract of landwas conveyed on October 25, 1947, to Vermon Young and wife, Sarah Ruth Young by warranty deed which is recorded in Deed Book 133, on page 45 in the office of the Judge of Probate of Shelby County, Alabama.

It is further understood and agreed by the parties hereto that all of the debts, liabilities contracts and accounts of the "Vendor" shall be and they are hereby assumed by the "Vendee".

TO HAVE AND TO HOLD unto the "Vendee", the said Shelby Iron Company of Alabama, its successors and assigns, all and singular, the properties real, personal and mixed, and of whatsoever kind or character, corporeal or incorporeal, hereby conveyed or intended so to be conveyed, in fee simple, forever.
