The North East Quarter of the North East Quarter, less the South 10 acres, Section 1, Township 22, South, Range 3 West.

The East Half of the South East Quarter, Section 36, Township 21 South, Range 3 West.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said line of poles, towers and appliances on lands of grantors hereim bove described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established Grore-established from time to time.

Together with all the rights and ingress necessary or convenient for the full enjoyment or use thereo of, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
