That certain lot containing 2 acres, more or less, in a square which forms the southeast corner of Calera or 16th Street and Smith Street on 20th Avenue; said lot fronting 295.6 feet along the east side of said 16th Street and extending back in an easterly direction of uniform width 295.6 feet with the north line of said lot being the south line of said 20th Avenue;

Also Lots 1 and 2 in Block 261 according to Dunstan's Survey of the Town of Calera, Alabama; said lot one faces 50 feet along the west side of 15th Street south and extends back in a westerly direction of uniform width 145 feet and 9 inches, the north and south lines of said lot 1 being parallel with 21st Street; said lot 2 extends along 15th Street south 55 feet and 9 inches and extends back in a westerly direction of uniform width 145 feet and 9 inches, the north and south lines of said lot 2 being parallel with 21st Street;

Also all of our interest in and to Block 247 according to Dunstan's Survey of the Town of Calera, Albama;

Also lots 1 through 8 in Block 256 according to Dunstan's Survey of the Town of Calera,
Alabama; said lots each facing 50 feet along the west line of 15th Street south and extending back west of uniform width 150 feet;

all being situated in Shelby County, Alabama.
