KNOW ALL MEN BY THESE PRESENTS, That in consideration of Fifty Three Hundred & No/100 Dollars to the undersigned grantors, S.J. Kendrick and Annie L. Kendrick, in hand paid by Hampton D. Lee & Exie Patrick Lee the receipt whereof is acknowledged we the said S.J. Kendrick & Annie L. Kendrick do grant, bargain, sell and convey unto the said Hampton D. Lee & Exie Patrick Lee the following described real estate, to-wit:

A certain piece or parcel of land (with exception noted below) situated in the town of Montevallo, Alabama, which lays in a body of land described in a certain plot recorded in Plot Book, Page 114, in Judge of Probate Office, Shelby County, by H.C. & W.B. Reynolds, on Apl. 2, 1900. Reference is hereby made to said plot as recorded for the descriptions that hereinafter follow. All of the land as described in said plot lying south of Bowie Street and including all of Bowie Street, being more accurately described as Blocks G, H, I, J, K, L, M, N, and all that part marked on said plot as "Manufacturing Reserve" together with all of Stallings Street, all of Graham and Quarles Streets, and all of Waller and Samford Streets, lying south of Bowie Street, also all the alleys in and between said blocks above named. The said land being bounded on the north by Bowie Street and including said Bowie Street, on the east by the road leading from Shoal Creek to the Southern Railway Company, being described on said plot as Shelley Street, and on west by the Morgan farm, and on south by the Southern Railroad. It being in NE 1/2 of Section 4, T-24, R 12E. It is understood that the map herein before referred to has been vacated as provided by law, and that any dedication of streets, alleys, and public easements growing out of the same, have been annulled, and that reference hereinbefore made to said map streets, alleys, and lots are not to be construed as recognizing any remaining right in the public to any part , except the following plot of land which has been sold and is hereby omitted from this deed: Beginning at the intersection of the south side of Shelley Street, with the right of way line of the Southern Railway Co. thence in a westerly direction along margin of said Shelley Street, a distance of 210 ft. thence in a southerly direction at right angles, and perpendicular to Shelley Street, a distance of 360 ft. thence at right angles and East 210 ft, to right of way line of Southern Railway Co. thence north and along margin of said right of way of Southern Railway Co, 360 ft. to point of beginning,

situated in Shelby County, Alabama.

TO HAVE AND TO HOLD To the said Hampton D. Lee & Exie Patrick Lee, his their heirs and assigns forever.

And we do, for ourselves, and for our heirs, executors, and administrators, covenant with the said Hampton D. Lee & Exie Patrick Lee, his their heirs and assigns that we are lawfully seized in fee simple of said premises, that they are free from all incumbrances; that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors, and administrators, shall warrant and defend the same to the said Hampton D. Lee & Exie Patrick Lee, their heirs and assigns forever, against the lawful claims of all persons.
