Containing in all sixty acres, more or less.

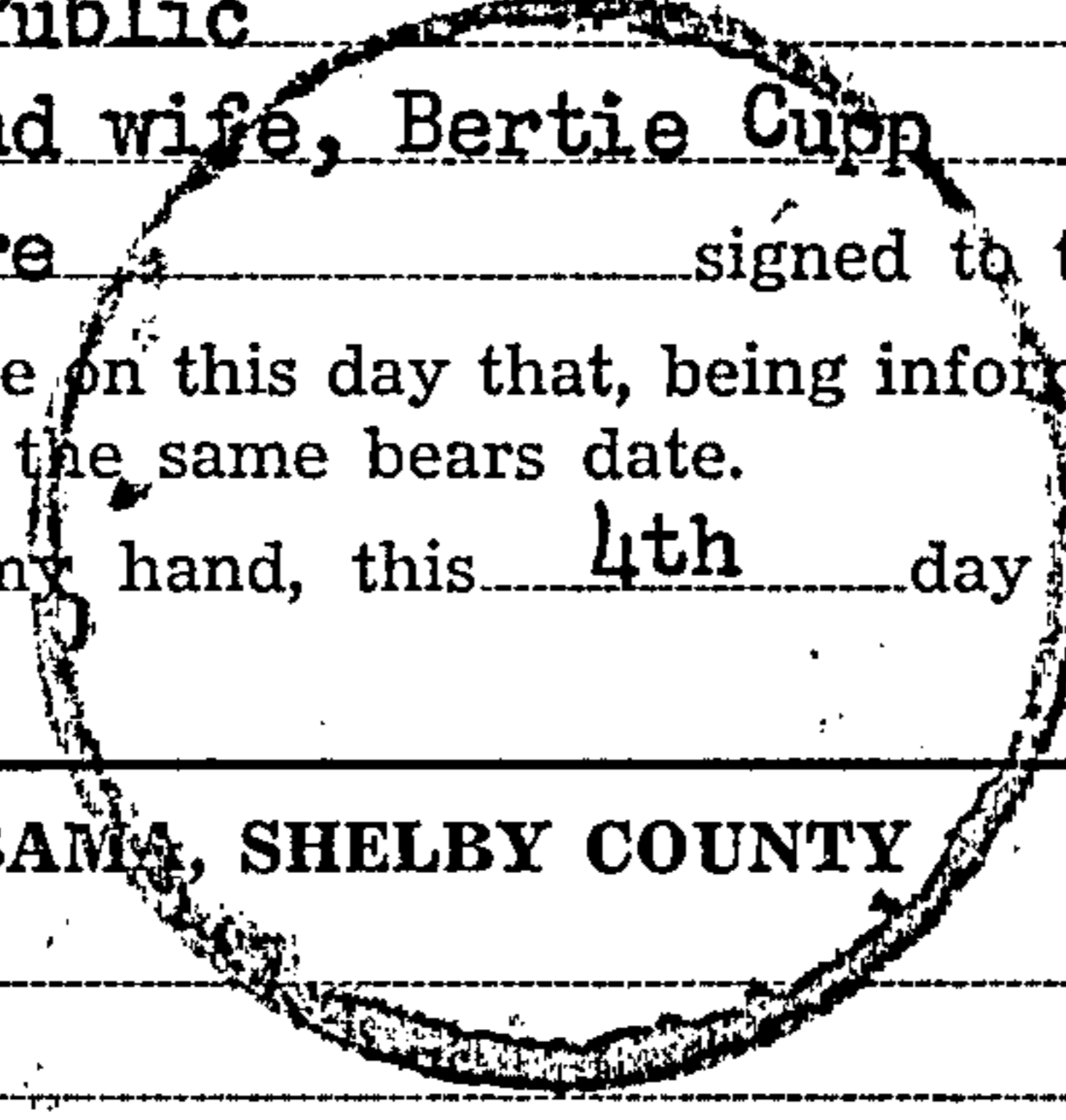

J.E. King, his heirs and assigns forever, against the lawful claims of all persons.

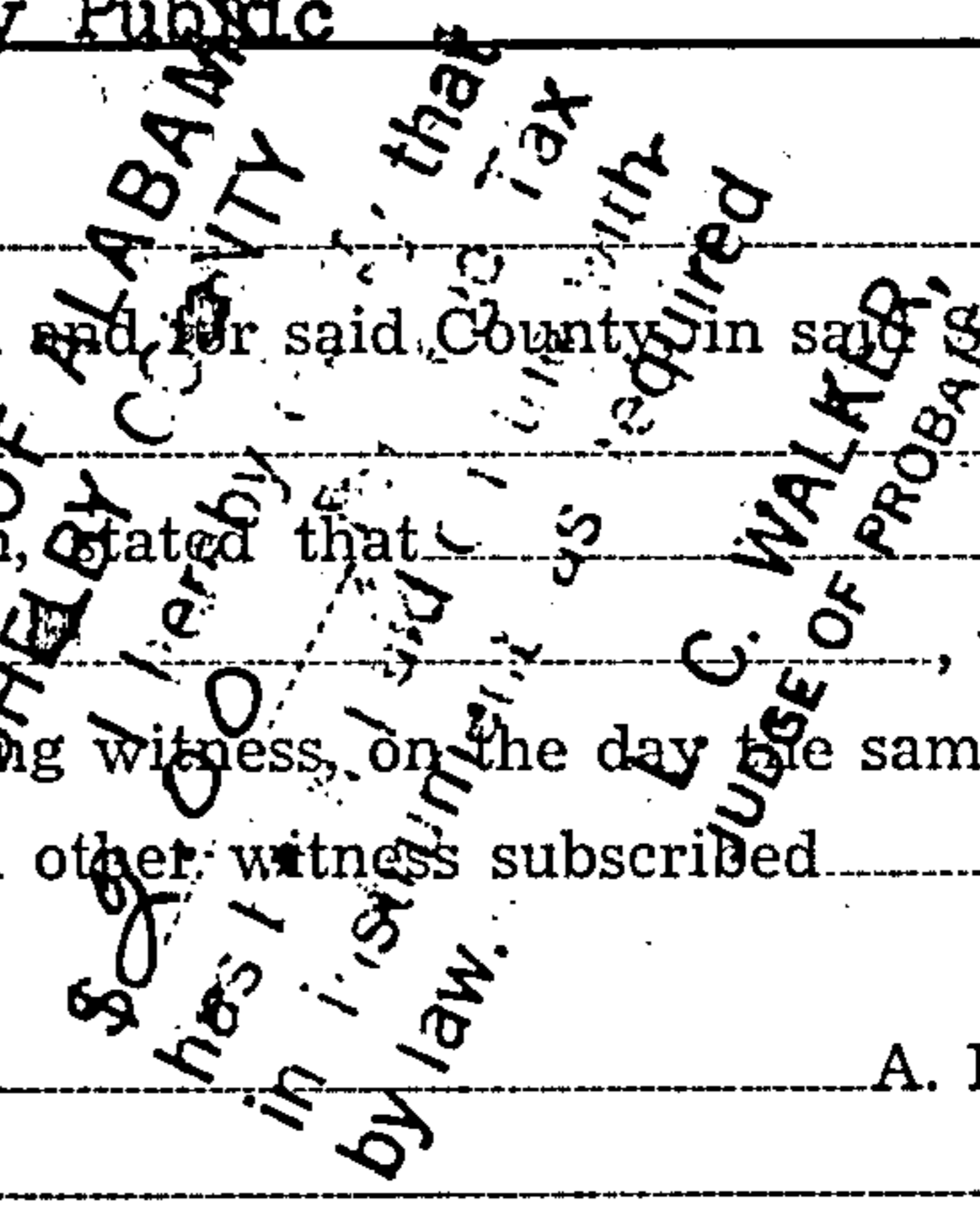
