do grant, bargain, sell and convey unto the said A.J. Poole Jr., and wife, Elizabeth Denty Poole,

the following described real estate, to-wit: That certain tract of land described as commencing at the northwest corner of the Northeast quarter of the Northeast quarter of Section 15, Township 19, Range 2 West, and run thence East along the North line of said forty acres, a distance of 211 feet to an iron stake for the point of beginning of the lot herein described and conveyed; Run thence in a Southerly direction a distance of 528 feet to a point 197 feet East of the West line of said forty acres; run thence East and parallel with the North line of said forty acres; a distance of 197 feet; run thence in a Northerly direction a distance of 528 feet, more or less, to a point on the North line of said forty acres, which is 211 feet East of the point of beginning of the lot herein described and conveyed; run thence west along the North line of said forty acres, a distance of 211 feet to the point of beginning, and containing  $2\frac{1}{2}$  acres, more or less.
