AFFIDAVIT

Before the undersigned authority personally appeared B. B. Mooney, who is known to me and who being by me first duly sworn deposes and says:

I am acquainted with the NEt of SEt, Nt of NWt of SEt, and Nt of NEt of SWt, all in Section 34, Township 21, Range 1 East, Shelby County, Alabama. I have known this land practically all my life and own land adjoining it. This property formerly belonged to R. A. Atkinson who sold it to Ly K. To Clemons and Clemens sold it to Ruby Robertson and Ruby Robertson sold it to H.I. E. Dyer and Dyer sold it to W. M. Cylloway who in turn sold it to A. A. English and Isaac J. English. All these transactions were evidenced by deeds. The deed to A. A. English and Isaac J. English was dated September 8, 1948, and to my personal knowledge they and those through whom they claim title have been in actual, open, notorious, continuous, exclusive, adverse possession of the same, claiming to own it and living upon it and cultivating portions of it or having tenents upon it and cultivating portions of it each and every year during all that time.

I am also acquainted with the SW2 of SE2, the S2 of NW2 of NW2, and the S2 of NW2 of SW2, Section 34, Township 21, Range 1 East, Shelby County, Alabama, and have known this land practically all my life. This land is known as the Ellison Place. On the 19th day of November, 1935, T. D. Wycoff executed a deed to this property to E. W. Ellison and Lula Ellison, which deed is recorded in the Probate Office of Shelb y County, Alabama, in Ded Book 94, at page 572. The Ellisons went into possession of this property immediately after they received the deed from Mycoff and remained in actual, open, notorious, continuous, exclusive, adverse possession, cultivating portions of it or having portions of it cultivated each and every year until they deeded it to W. M. Callaway and Ruby Callaway, which deed is recorded in the Probate Office of Shelby County, Alabama, in Deed Book 116 at page 492. The Callaways deeded theproperty to A. A. English and Isaac English by deed dated September 8, 1948, and recorded in the Probate Office of Shelby County, Alabama, in Deed Book 126, at page 418. During the time the Callaways owned the property they were in the actual, open, notorious, continuous, exclusive, adverse possession of same cultivating the same or portions thereof; or having it done each and every year until they deeded it to A. A. English and Isaac English.
