~~Xix~~ To-wit the S W $\frac{1}{4}$ of N E $\frac{1}{4}$ of Section 18, Township 20, Range 3, West, except the North 17 Rods of said Forty, Also the North 17 Rods of N W $\frac{1}{4}$ of S E $\frac{1}{4}$ of Section 18, Township 20, Range 3 West. and as follows- A Tract of land off of the North end of the S E $\frac{1}{4}$ of the Nor East $\frac{1}{4}$ of Sec 18, Township 20, South Range 3 West, Beginning at the N W Corner of said above mentioned (40) Acres and run East 1320 feet, t o A Sec line thence South along said Section line 17 Rods, Thence run West 1320 feet to A Forty Line, Thence North along said Forty Line 17 Rods to Point of Beginning.

Third. I will and bequeath to my beloved wife all the rest and residue of my estate, real, personal and mixed.
