DEED OF CORRECTION

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, under date of September 24, 1918 the undersigned, J. R. NOW, THEREFORE, solely for the purpose of correcting said deed, as herein stated, with respect to the property hereby conveyed only, the said J. R. Allan and wife, Sudie Allan, do hereby remise, release, quit claim and convey unto Hattie Dunaway the NE_{4}^{1} of the SW_{4}^{1} of Section 11, Tp 19 South, Range 2 West, minerals and mining rights and privileges excepted, situated in Shelby County, Alabama, to have and to hold unto the said Hattie Dunaway, her heirs and assigns forever; and

For the same consideration we, the said J. R. Allan and wife, Sudie Allan, do hereby remise, release, quit claim and convey unto M. O. Ledhetter and Mary Sultana Ledbetter the NW4 of the SW4 of Section 11, Tp 19 South, Range 2 West, situated in Shelby County, Alabama, minerals and mining rights and privileges excepted.

TO HAVE AND TO HOLD unto the said M. O. Ledbetter and Mary Sultana Ledbetter, their heirs and assigns forever.
