WHEREAS, under date of December 30, 1936, W. B. Baker and wife Jennie C. Baker, W. B. Baker & Sons, Inc., and Baker Land Company executed a deed of trust to W. B. Baker and G. G. Baker as Trustees, which Deed of Trust is recorded in Volume 2844, page 177 in the Record of Deeds in the Office of the Judge of Probate of Jefferson County, Alabama, and in Volume 104, page 1 in the Record of Deeds in the office of the Judge of Probate of Shelby County, Alabama, and under date of October 28, 1943 one of the said Trustees designated in said Deed of Trust, namely W. B. Baker, died, and no successor to him as Trustee has been appointed, and said Deed of Trust provides that a majority of the then living specifically named beneficiaries shall have power to appoint a new Trustee or Trustees to succeed any deceased Trustee and that thereupon such successor trustee shall be vested with all of the right, duties, powers and privileges vested in the original trustee, by instrument in writing duly acknowledged.

Baker shall be and is hereby vested with all of the rights, duties, powers and privileges vested in the said deceased trustee.

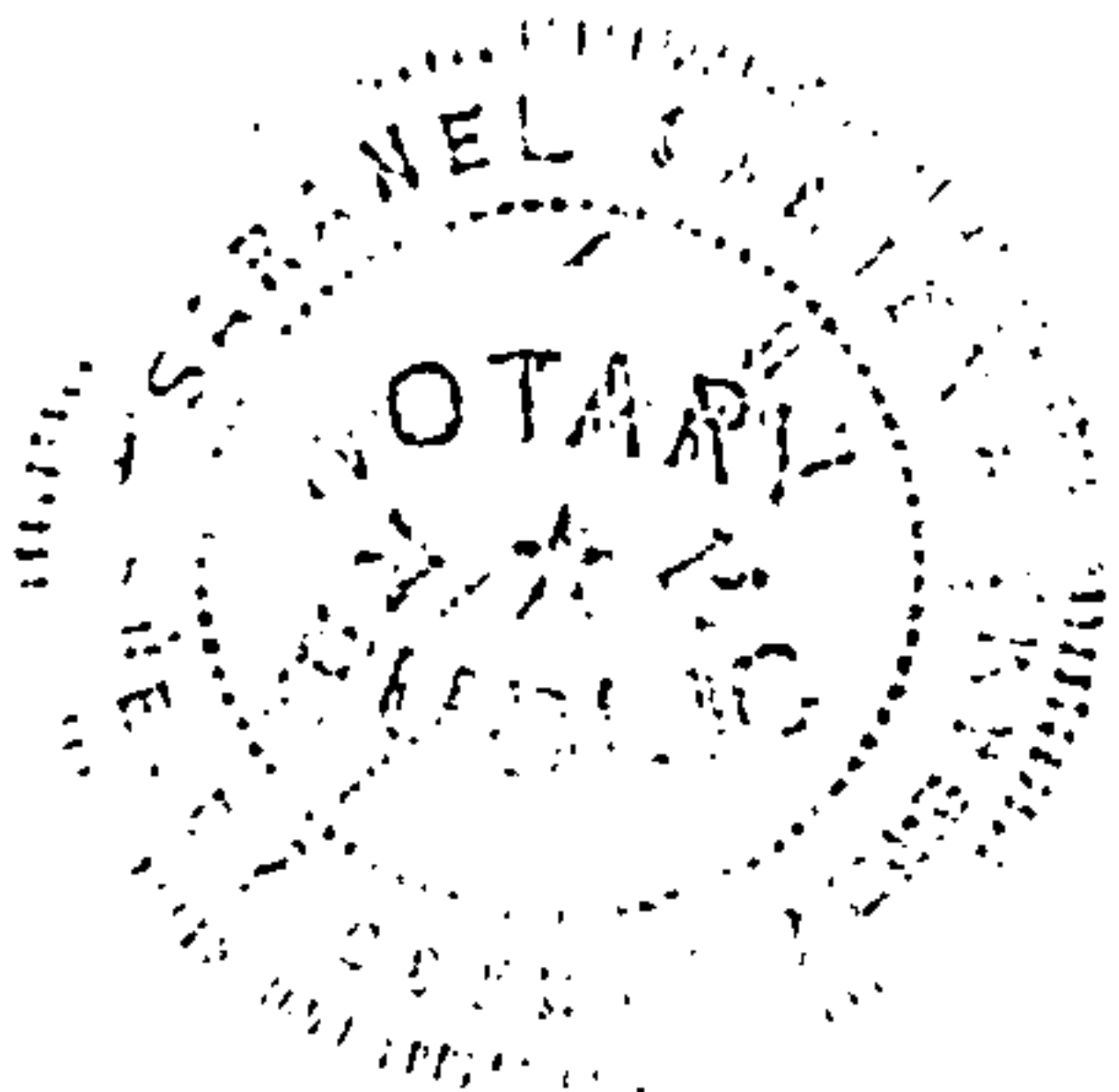
