of way for the purpose of construction, reconstructing, maintaining, and repairing

a Gas Line together with all necessary right

of access, ingress and egress thereto and therefrom, in, under, over, and along the following described property: Part of lots 33 and part of lot 32 Original

Plan of Town of Montevallo Described as follows: Begin intersection of

NE side of Vine Street with SE side of Main Street which is NW corner

of Masonic Oldge Bldg and run NE along SE side of Main Street 30 feet

to point of beginning; thence angle of 90 deg to right and run 95 feet;

thence NE parallel to Main Street 45 feet to SW wall of Bldg owned by

N. Joe Klotzman; thence NW parallel to Vine Street 95 feet; to Main Street;

thence SW along Main Street 45 feet to beginning.
