a Gas line together with all necessary right

of access, ingress and egress thereto and therefrom, in, under, over, and along the following described property: Part of lots 40 and 41 Original Plan of

town of Montevallo described as: Begin 109 $\frac{1}{2}$  feet from NW corner store

house said point being on NE side of Shelby Street; and run SE along

NE side of Shelby Street to a point 145 feet NW of intersection of




