KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of one dollar (\$1.00), to the undersigned grantor R. O. Bean and wife (~~XXXXXX~~) Newell Audrey Bean in hand paid by the Town of Montevallo, a municipal corporation, the receipt whereof is hereby acknowledged, the said R. O. Bean and wife (~~XXXXXX~~) Newell Audry Bean do grant, bargain, sell and convey unto the said Town of Montevallo an easement and right of way for the purpose of construction, reconstructing, maintaining, and repairing a Gas line together with all necessary right of access, ingress and egress thereto and therefrom, in, under, over, and along the following described property:

Part of lot 21 Original Plan of Montevallo described as: Begin at SW margin of Middle Street 200 feet NW of East most corner of lot 21 and run SW perpendicular to Middle Street 75 feet; thence NW parallel with Middle Street 12½ feet to point of beginning; thence continue NW 12½ feet; thence NE 75 feet to Middle Street; thence SE along SW side Middle Street 12½ feet; thence SW perpendicular to middle Street 75 feet to beginning.

Situated in Shelby County, Alabama

TO HAVE AND TO HOLD, the said easement and right of way hereinabove granted to the said Town of Montevallo its successors and assigns forever, for the use and purpose aforesaid and for no other purpose.
