Before the undersigned authority personally appeared E. F. Brasher, who is known to me and who being by me first duly sworn deposes and says:

A. A. Brasher and Mahaley Brasher, who were the grantees in that certain deed executed by M. R. Gable and B. T. Gable on November 8, 1893, which is recorded in the Probate Office of Shelby County, Alabama, in Deed Book 21, page 531, were my father and mother. My father died about three years ago. He left no Will and there has been no administration of his estate. After my mother died my father married again and his widow is now dead. She died in April, 1951. My mother died first and after her death all the heirs at law and next of kin of Mahalley Brasher deeded the property to said A. A. Brasher, my father.

A. A. Brasher had nine children as follows:

1. Ernest F. Brasher, a son (affiant);
2. Earl Brasher, a son;
3. Gurnie Brasher, a son who is now dead. He died before my father did.
4. Delphia Brasher Tumlin, a daughter;
5. Lossie Brasher Donahoo, a daughter;
6. Flossie Brasher Peeples, a daughter;
7. Florence Brasher Randall, a daughter;
8. Vonzell Brasher Vogala, a daughter;
9. Ethel Brasher Johnson, a daughter.

Said Gurnie Brasher died before my father did and left surviving him as his sole heirs at law and next of kin children as follows:

- a. Thomas Brasher, a son;
- b. Cecil Brasher, a son;
- c. Jessie Brasher, a son;
- d. Willie Clyde Brasher, a son;
- e. Lossie Brasher, a daughter who has recently married;
- f. Ruby Nell Brasher, a daughter who has recently married.

All of the above named children of A. A. Brasher are over twenty-one years of age and the children of said Gurnie Brasher are all over twenty-one years of age.

My attention is called to a recorded judgment against T. R. Brasher in favor of Lelias E. Kirby. This judgment is recorded in the Probate Office of Shelby County, Alabama, in Judgment Record "E" at page 283. Said T. R. Brasher is in no way related to A. A. Brasher and, likewise, Fred Brasher against whom a Certificate of Lien for taxes is recorded in the Probate Office of Shelby County, Alabama, in Judgment Record "E" at page 385, is in no wise related to A. A. Brasher.

I am acquainted with the S 1/2 of the SW 1/4 of SW 1/4, Section 34, Township 19, Range 1 West, Shelby County, Alabama.

A. A. Brasher was in possession of said land, living upon it and cultivating portions of it for forty years prior to his death, except certain portions thereof he sold to J. T. Johnson and wife, Ethel Johnson, Velma Nabors Jones, Sam Peeples, and E. R. Bradbery and wife, Blanche Bradbery. During all that time neither Daniel Salser, Rose Ann Salser, Henry Blackerby, W. J. Tinney, Sallie B. Tinney, nor W. H. Boynton, were in possession of said property or any portion thereof but A. A. Brasher up to the time of his death was in the actual, open, notorious, exclusive, hostile, adverse possession of said property with the exceptions noted, cultivating portions of it and living upon it each and every year.
