I am a daughter of W. H. Pope, who is grantee in that certain deed executed by E. H. Immediately after the execution of said deed my father moved into the dwelling house on said property and he and his family continued to reside therein until the time of his death which occurred on or about the 15th day of May, 1939, and since his death his widow, my mother, continued to reside in the dwelling house on said property until she died September 17, 1948, and since her death I have been living in the dwelling house on said property continuously, recognizing of course the rights of my two sisters, Evelyn Pope Smith and Clarkie Pope (Harriett Clark Pope), who were joint owners with me of the property under my father's Will. My mother was Stella T. Pope.

The property in question is known as the old George W. McGowen residence lot. His widow, Sallie E. McGowen died about the year 1929.
