I am acquainted with the following described real estate situated in Saginaw, Shelby County, Alabama, and have known the same thirty-five or forty years and during all that time I have lived in the community where this land is situated, viz:

That part of the SW 1/4 of SW 1/4 of Section 7, Township 21, Range 2 West, described as follows, to-wit: Begin at the intersection of the line of Range 2 West between Section 7 and 12 in Township 21 and the South boundary line of the South and North Ala RR Co's r/w and run south along said range line 420 feet; thence E 210 feet; thence due north 420 feet to the south boundary line of said S & N Ala. RR Company and thence west along said boundary line of said S & N RR Co's r/w 210 feet to point of beginning and containing 2 acres being in the SW 1/4 of SW 1/4 of Section 7, Township 21, Range 2 West, Shelby County, Alabama, except part sold to Longview-Saginaw Lime Works, Inc. in 1941.

I married a daughter of Dr. G. H. Smith and along with her I executed the deed to Mr. Fulton and have personal knowledge of all the facts
