For value received, THE FEDERAL LAND BANK OF NEW ORLEANS, being the present owner of the indebtedness secured by that certain mortgage or deed of trust executed by Ernis B. Lucas, recorded in Book 195, Page 112, of the land mortgage records of Shelby County, Alabama, does hereby release from said mortgage (deed of trust) the following:

- (a) Commencing at the Northeast Corner of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 7, Township 24, Range 13 East, and run South 660 feet; run thence West 420 feet to a point of beginning of the lot herein conveyed and described: run thence South 105 feet; run thence West 210 feet; run thence North 105 feet; run thence East 210 feet to point of beginning, and containing $\frac{1}{2}$ acre.
- (b) Beginning at a point 660 feet South of the Northeast Corner of the Southeast $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 7, Township 24, Range 13 East, and run West 210 feet to a point run thence South 105 feet; run thence East 210 feet to the East Line of said 40 acres; run thence North 105 feet to point of beginning, and containing $\frac{1}{2}$ acre.
- (c) Also, a tract of land commencing at the NE corner of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 7 Township 24, range 13 East, and run thence South 660 feet; run thence West a distance of 660 feet to the point of beginning of the tract of land herein described: Run thence West 210 feet; thence South 105 feet; run thence East 210 feet; run thence North 105 feet to the point of beginning, and containing $\frac{1}{2}$ acre.
