


DEED, STATUTORY WARRANTY

the receipt whereof is acknowledged We the said Willie L Chambless and husband
C.O. Chambless and J.O. Anderson & Wife Mary E Anderson
do hereby grant, bargain, sell and convey unto the said

M. L. Canady

Pine Timber

the following described ~~hereinafter~~ to-wit: All the Pine timber that is located, and
being 8 inches in diameter, 8 inches from the ground, on the
following described real estate; West 15 acres, Section 29, Tp. 21
~~range 2 w. West one-half of South west quarter of Section 27, Tp. 21~~
Range 2 west. (Timber in Section 28, Tp. 21 Range 2 west, Not sold
to Durden, if any. Grantee to verify records at Courthouse, if none
owned Sec. 28 void.) Southeast quarter, and the Southwest of Northeast
quarter, and West 15 acres of Northeast quarter of Northeast quarter, all
in Section thirty-two Tp. 21 Range 2 W. -- West one-half of West one-half
not heretofore sold, of Section 34, Tp. 21 Range 2 W. -- Northwest quarter
of Northwest quarter, the west one-half Northeast quarter of Northwest
