THIS INDENTURE made and entered into this 6th day of November, 1930, by and between the SHELBY IRON COMPANY, a corporation organized under the laws of the State of New Jersey, hereinafter for convenience sometimes referred to as the "Vendor", party of the first part, and the SHELBY IRON COMPANY OF ALABAMA, a corporation organized under the laws of the State of Alabama, hereinafter for convenience sometimes referred to as the "Vendee", party of the second part.

WITNESSETH, WHEREAS, the President and Secretary of the Shelby Iron Company, a New Jersey corporation, by resolution of the Board of Directors of said Company approved and consented to by more than two-thirds of its stockholders in interest at meetings called for that purpose, all as provided by the laws of the State of New Jersey, have been duly authorized to execute under the seal of the corporation such instruments as may be necessary to effectually convey all of the properties, real, personal and mixed, of the said Company to the Shelby Iron Company of Alabama, an Alabama corporation;

NOW, THEREFORE, for and in consideration of the payment of One Dollar (\$1.00) by the "Vendee" to the "Vendor", the receipt of which is hereby acknowledged, and in further consideration of the performance of the terms, conditions, covenants and agreements herein-after set out, the "Vendor" does grant, bargain, sell, convey, release, remit, quit-claim and convey to the "Vendee" all of its properties, real, personal and mixed, and of whatsoever kind or character, corporeal or incorporeal, located in the State of Alabama or elsewhere, which properties are more specifically described in Schedule "A" hereto attached, it being understood and agreed, however, that if any of the said properties of the "Vendor" shall have been omitted from the said Schedule "A", such properties shall be deemed to have been as effectually conveyed by this instrument as if the said properties had been included and described in the said Schedule "A".

It is further understood and agreed by the parties hereto that all of the debts, liabilities, contracts and accounts of the "Vendor" shall be and they are hereby assumed by the "Vendee".

TO HAVE AND TO HOLD unto the "Vendee", the said Shelby Iron Company of Alabama, its successors and assigns, all and singular, the properties real, personal and mixed, and of whatsoever kind or character, corporeal or incorporeal, hereby conveyed or intended so to be conveyed, in fee simple, forever.

IN WITNESS WHEREOF, the parties hereto by their respective officers thereunto duly authorized, have executed this indenture under the seals of their respective corporations the day and year first above written.
