My father and mother both have been dead for many years. My father and mother had five children, namely, Mary Anderson, who died at the age of thirteen; Will S. Anderson, affiant; Augusta Virginia Anderson; Eliza C. Anderson, and John H. Anderson. The last four children were the sole heirs at law of my father and mother at the time of their respective deaths.

Anderson, both being unmarried at the time, deeded a part of above described land to affiant by deed of September 27, 1912, which is recorded in Deed Book 51 at page 413 in the Probate Office of Shelby County, Alabama. Also one and the same person as Eliza A. Roddy, who with Mattie M. Anderson, widow of John H. Anderson conveyed above described property with other property to Tom J. Jennings and wife Fannieal Cater Jennings, by deed of June 11, 1951, which is recorded in said Probate Office in Deed Book 148 at page 535.
