This indenture made on this the 18th day of January, 1952, between Marie Brown Shogren, and wife, Marie Brown Shogren
Gerald Clifford Shogren acting by and through his attorney in fact, /

parties of the first part and the Town of Columbiana, Alabama, party of the second part, witnesseth:

That the parties of the first part in consideration of \$1.00 and other good and valuable consideration paid by the party of the second part, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey unto the party of the second part, its successors and assigns forever a right of way of sufficient width to properly construct, maintain and operate a sewer line, including manholes, over and under the hereinafter described land, the center of said right of way being described as follows:

Commence at the southeast corner of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 26, Township 21 South, Range 1 West, thence south along the east line of NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of said Section 26 run 16.08 feet; thence south, 86 degrees 31 minutes west, 445.2 feet to a point; thence continue in the same direction 78 feet to a point; thence south, 79 degrees 10 minutes west, 142 feet to the east line of F. E. Williams lot; thence continue south, 79 degrees 10 minutes west, 52.75 feet to a point; thence north, 69 degrees 14 minutes west, 28.4 feet to the east line of Alabama State Highway No. 25; thence north, 69 degrees 14 minutes west, 50 feet to the west line of said highway to the point of beginning; thence continue north, 69 degrees 14 minutes west, 124.1 feet to the easterly right of way line of the L & N Railroad; being situated in Shelby County, Alabama.

The same to be used by said party of the second part, its successors and assigns for all such purposes and for only such purposes as are incidental to the construction, maintenance and operation of a sewer line and manholes over and under said land.
