the receipt whereof is acknowledged we the said T. W. Stubbs and wife Mabel W. Stubbs

do grant, bargain, sell and convey unto the said Lorraine Stubbs Hardin

the following described real estate, situated in Shelby  
County, Alabama, to-wit:

Commence at the Southeast corner of Southeast Quarter (SE $\frac{1}{4}$ ) of Northeast Quarter (NE $\frac{1}{4}$ ), Section 2, Township 20 South, Range 3 West and run north along east boundary of said quarter-quarter section for a distance of six hundred sixty-three and four tenths (663.4) feet to point of beginning; thence continue north along east boundary of said quarter-quarter section for a distance of three hundred thirty-one and seven tenths (331.7) feet to a point; thence on an angle of Eighty-seven degrees and Fifty-eight minutes (87° 58') left.
