Second: I give, devise and bequeath all the rest, residue and remainder of my estate, real personal and mixed wheresoever situated of which I might die seized and possessed, or to which I might be entitled at the time of my death to my beloved children, Namely: ALEF E. WHITFIELD, ADDIE MAE SMITH, MAE VANN GANDY, VIVIAN VANN COXER, LOU ALICE LUMPKIN, PERRY JAMES VANN and JOHN H. VANN, in equal shares to each, to have and to hold the same to them absolutely and forever.

Third: I hereby nominate, constitute and appoint my daughters, Mae Vann Gandy, Vivian Vann Coker and Lou Alice Lumpkin, joint executrices of this my last Will and Testament and direct that they shall not be required to make bond.
