Act of Congress of the 24th of April, 1820, entitled "An act making further provision for the sale of the Public Lands," for the North West quarter of the South West quarter of Section Twenty Six, the North East quarter of the North East quarter, the South West quarter of the North East quarter, and the North East quarter of the South East quarter of Section Twenty Seven, in Township Twenty of Range Two West, in the District of Lands Subject to Sale at Tuscaloosa, Alabama, containing One Hundred and Sixty acres and Eleven hundredths of an acre.

according to the official plat of the Survey of the said Lands, returned to the General Land Office by the SURVEYOR GENERAL, which said tracts have been purchased by the said Chesley Payne.

and to his heirs, the said tracts above described: To have and to hold the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said Chesley Payne

and to his heirs and assigns forever.
