Act of Congress of the 24th of April, 1820, entitled "An act making further provision for the sale of the Public Lands," for the North East quarter of the North East quarter and North East quarter of the South West quarter of Section two, in Township twenty two, of Range one, West, in the District of Lands, Subject to sale at Tuscaloosa, Alabama, containing twenty nine acres, and ninety nine hundredths of an acre,

according to the official plat of the Survey of the said Lands, returned to the General Land Office by the SURVEYOR GENERAL, which said tracts have been purchased by the said *Jackson Porter,*

and to *his* heirs, the said tracts above described: To have and to hold the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said *Jackson Porter*

and to *his* heirs and assigns forever.
