I, the undersigned W. B. Blevins, Town Clerk of the Town of Calera, Alabama hereby certify that at a meeting of the Mayor and Town Council, of the Town of Calera, held in the Town of Calera on the 25th day of April, 1953 the following resolution was duly presented, seconded and adopted:
