Know Ye, That in pursuance of the Act of Congress, entitled "An Act to raise for a limited time an additional military force, and for other purposes," approved February 11th, 1847.

having deposited in the GENERAL LAND OFFICE a WARRANT in *his* favor, numbered *10,525*

THERE IS THEREFORE GRANTED BY THE UNITED STATES, unto *Jelmon C. Holston* Assignee of said *Robert M. Holmes*, and to his heirs, the West Half of the Northeast Quarter, and the East Half of the Northwest Quarter of Section Thirty-Two, in Township Twenty Four of Range Eleven East, in the District of Lands subject to sale at Tuscaloosa, Alabama, containing One Hundred and Fifty Nine Acres, and Seventy Two Hundredths of an Acre.

according to the Official Plat of the Survey of the said Land returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL, which said tract ~~has~~ been located in satisfaction of the above mentioned Warrant, in pursuance of the Act of Congress above mentioned, approved February 11th, 1847. TO HAVE AND TO HOLD the said ~~part of said~~ section of land, with the appurtenances thereof, unto the said *Jelmon C. Holston and to his*

heirs and assigns forever.
