Block No. 254 and west half of Block No. 255 according to J. H. Dunstan's Survey of the
Town of Calera, Alabama, and being more particularly described as follows: Beginning at the
southwest corner of Block No. 254, which is the northeast corner of the intersection of
22nd Avenue and 18th Street South; thence north, 5 degrees 09 minutes west, along the
east side of 18th Street South 400 feet to the northwest corner of Block No. 254, said
point being the southeast corner of the intersection of 21st Avenue and 18th Street
South; thence north, 89 degrees 15 minutes east along the south side of 21st Avenue
a distance of 536 feet, more or less, to the northeast corner of Lot No. 9 of Block
No. 255; thence south, 5 degrees 09 minutes east, along the west side of an alley 400
feet to the southeast corner of Lot No. 16 of Block No. 255; thence south, 89 degrees 15
minutes west along the north side of 22nd Avenue for a distance of 536 feet, more or
less, to the point of beginning; being situated in Calera, Shelby County, Alabama.
