Third: Frank C. Bonham, Sr. is the general partner and resides at Route 14, Box 890, Birmingham Zone 8, Alabama, and M. C. McQueen is the special partner and resides at Route 2, Camden, Alabama.

Fourth: The said special partner has contributed to the capital stock of the firm \$ 5,000⁰⁰.
