Currie, do grant, bargain, sell, and convey unto the said Dixie Lime and Rockwool Company, Inc. the real estate situated in Shelby County, Alabama, in the SE $\frac{1}{4}$  of Section 14, Tp. 20, R3 West, and described as:

## PARCEL 1

That part of the E $\frac{1}{2}$  of the SE $\frac{1}{4}$  of said Section 14, which lies South and West of the right of way of the A.B. & C. R.R. and North and East of the old location of the public road leading from Pelham, Alabama, to Helena, Alabama; and also,

## PARCEL 2

That part of the W $\frac{1}{2}$  of the SE $\frac{1}{4}$  of said Section 14, described as beginning at the SE corner of the L & N R.R. Company's section house lot; then along the right of way of the L & N R.R. A strip of the uniform width of 56 feet lying evenly along the North and South center line of the SE $\frac{1}{4}$  of Section 14, and lying South of the A.B. & C. Railroad right of way, and North of the old Tuscaloosa Road, all of said strip of the width of 56 feet lying West of the North and South center line of the SE $\frac{1}{4}$  of Section 14.
