DECLARATION OF VACATION

WHEREAS the undersigned PAUL O. LUCK is the owner of all of Lot No. 12 in Block 197, according to Dunston's map of the Town of Calera, Alabama, which said Lot No. 12 abutts on the north side of 17th Avenue according to said plat; and

WHEREAS the undersigned J. O. ANDERSON and C. O. ~~CHAMBERLESS~~ *Chambless as Executor* are the owners of all of Lot No. 1 in Block 197, according to Dunston's map of the Town of Calera, Alabama, which said Lot No. 1 also abutts on the north side of 17th Avenue; and

WHEREAS the said J. O. ANDERSON and C. O. ~~CHAMBERLESS~~ *Chambless as Executor* are also the owners of Lots No. 8 and 9 in Block 208, according to Dunston's map of the Town of Calera, Alabama, which said Lots No. 8 and 9 abutt on the south side of said 17th Avenue; and

WHEREAS said owners desire to vacate all that portion of said 17th Avenue described as follows:

Begin at the southeast corner of Block 197 according to Dunston's map of the Town of Calera and run thence 180 feet in a westerly direction along the south line of said Block 197 to the point of beginning; from said point of beginning run south and perpendicular to the south line of said Block 197 a distance of 50 feet, thence west and parallel with the south line of said Block 197 a distance of 50 feet, thence

north and perpendicular to the south line of said Block 197 a distance of 50 feet, thence east to the point of beginning, all of which is situated in the Town of Calera in Shelby County in the State of Alabama; and

WHEREAS the only properties abutting said portion of 17th Avenue desired to be vacated are the aforesaid Lots 1 and 12 in Block 197 and Lots 8 and 9 in Block 208; and

WHEREAS such vacation will not deprive other property owners of such rights as they may have of convenient means of ingress and egress to and from their property; and reasonable means of ingress to and egress from said property will be afforded to other property owners by the remaining streets, avenues, and alleys shown on the said Dunston's map of the Town of Calera, Alabama;

NOW, THEREFORE THIS DECLARATION WITNESSETH:

The undersigned do hereby declare that there shall be and hereby is vacated that part of 17th Avenue more particularly described as follows:

Begin at the southeast corner of Block 197 according to Dunston's map of the Town of Calera and run thence 180 feet in a westerly direction along the south line of said Block 197 to the point of beginning; from said point of beginning run south and perpendicular to the south line of said Block 197 a distance of 50 feet, thence west and parallel with the south line of said Block 197 a distance of 50 feet, thence north and perpendicular to the south line of said Block 197 a distance of 50 feet, thence east to the point of beginning, all of which is situated in the Town of Calera in Shelby County in the State of Alabama.
