## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of One Dollar (\$1.00) to the undersigned grantor, WESTINGHOUSE ELECTRIC CORPORATION, a corporation, in hand paid by SOUTHERN RAILWAY COMPANY, a corporation organized under the laws of the State of Virginia, the receipt whereof is acknowledged, the said WESTINGHOUSE ELECTRIC CORPORATION does by these presents, grant, bargain, sell and convey unto the said SOUTHERN RAILWAY COMPANY, the following described real estate situated in Shelby County, Alabama:

A right-of-way for the construction, maintenance and repair of a railway lead track and for the necessary grading and filling for the construction and maintenance thereof and the right of ingress and egress to and from the same, which right-of-way is more particularly described as follows:

Commence at the NE Corner of Section 6, Township 24, Range 13 East, run thence West along the North line thereof (some-. times called the Freeman line) 2,126.07 ft. to the intersection of said Freeman line with the Southwesterly line of the right-of-way of the Southern Railway; thence turn left 169 degrees, 19 minutes and run in a Southeasterly direction along said Southwesterly line of the Southern Railway rightof-way 98.24 ft. to the point of beginning of the right-ofway hereby conveyed; thence continue in a Southeasterly direction along said right-of-way line 109.47 ft.; thence turn right 160 degrees, 18 minutes (angle measured to tangent of a curve) and run in a Southwesterly direction along the arc of a curve to the left having a radius of 358.15 ft. and a central angle of 26 degrees, 56 minutes, a distance of 168.36 ft.; thence turn left 90 degrees (angle measured from the tangent of said curve) and run a distance of 15 ft.; thence turn right 90 degrees and run a distance of 554.35 ft. to a point on the North line of the 51.585 acre tract owned by the grantor which point lies 204.95 ft. West of the NE Corner of said 51.585 acre tract; thence turn right 33 degrees, 5 minutes and run in a Westerly direction along the North line of said 51,585 acre tract a distance of 146.56 ft.; thence turn right 146 degrees, 55 minutes and run 677.15 ft.; thence turn right 90 degrees and run a distance of 15 ft.; thence turn left 90 degrees (angle measured to tangent of a curve) and run along said curve, having a radius of 408.15 ft. and a central angle of 12 degrees, 19 minutes, a distance of 87.74 ft. to the point of beginning, said right-of-way containing 1.275 acres together with the right to operate trains, cars and locomotives over the same, but a safe and proper passageway for animals and farm vehicles 7 ft. in width shall be provided by grantee on or under said tracks;


