to the undersigned grantor Macauley Martin

the receipt whereof is acknowledged I the said Macauley Martin

do grant, bargain, sell and convey unto the said Macedonia Missionary Baptist Church and its successors

the following described real estate situated in Shelby County, Ala., to-wit:

A lot, which was originally known as Macedonia Missionary Baptist Church lot, the corners of which were established on or about 1850A. D., and which measures 247 feet which now runs parallel with State Highway No. 25, thence in a westerly direction 341 feet; thence in a southerly direction 247 feet to the well, which is in the southwest corner of said lot. Thence in an easterly direction 341 feet to the intersection of Highway No. 25 or starting point, containing 2 acres more or less, and being a part of the NW 1/4 of SE 1/4 and SW 1/4 of NE 1/4, Sec. 24, Township 18, Range 2 East.

It is hereby understood that this lot was conveyed for a place to hold Church services by the original Macedonia Missionary Baptist Church or its successors, and at any time there be a period of five years that there be no such meeting, this property will revert back to owner or her heirs.
