KNOW ALL MEN BY THESE PRESENTS, That Gulf States Paper Corporation, a corporation, for and in consideration of One & no/100 Dollars to it in hand paid by the Town of Calera, Alabama, a municipal corporation, the receipt whereof is hereby acknowledged, do grant, bargain, sell and convey unto the said Town of Calera, Alabama, a municipal corporation, the following described property, to-wit:

A right of way for the laying, construction and maintenance of a water pipe line, which said right of way is described as follows, and which said right of way shall be 5 ft. on either side of the center of the line described as follows:

Commence at the NW corner of the NE¹/₄ of SE¹/₄, Section 22, Township 22 South, Range 2 West, thence South 4° 10' East, 156.0' to point of beginning. From point of beginning run thence 90° to the left 1192.0 ft., thence 3° to the left 130.3 ft., thence 4° to the right 167.81 ft., thence 1° 30' to the left, 263.0 ft., thence 11° 30' to the left, 78.4 ft., thence 5° 30' to the right, 182.9 ft., thence 3° to the left 106.2 ft., thence 2° to the right 72.2 ft., thence 6° to the right 52.5 ft., thence 9° to the left 250.3 ft., thence 1° 30' to the right, 76.3 ft.

Said easement herein granted is situated partly in the NEt of the SEt of Section 22, Township 22 South, Range 2 West, partly in the NWt of SWt, Section 23, Township 22 South, Range 2 West and partly in the SWt of the NWt, Section 23, Township 22 South, Range 2 West.

It is understood and agreed that the grantee herein, its successors and assigns shall have the right to do and maintain thereon and thereunder necessary equipment, structures, pipes or pipe lines, or other devices necessary and incident to the purpose of conducting water from Baxley Springs for a water supply, to Calera, Alabama, together with the right to go over and along the same and the right of ingress and egress to and from all portions of the land from which the same is conveyed by this instrument.

The rights herein granted shall revert to grantor, its successors and assigns, in the event of abandonment of the use of said water pipe line during a continuous period of twelve (12) months time.

Said Town of Calera, Alabama, has erected a waterworks system for said municipality, a part of which runs under the easement herein granted, with the source of water supply to be obtained from Baxley Springs, and the pipe line right of way herein conveyed is to be used in connection with said project, and for and in consideration of the benefit to our property by reason of the construction and maintenance of said waterworks system, we hereby release said municipality, its agents, employees and officers from all consequential damages present and prospective, to our property, arising out of the construction, improvement, maintenance or repair of said water works system and said pipe line.

TO HAVE AND TO HOLD to said Town of Calera, Alabama, a municipal corporation, its successors and assigns forever.
