Personally appeared before, Wm. Hugh McEniry,
a Notary Public in for said county and state, the undersigned
who being first duly sworn, who deposes and says, as follows,
to-wit:

My name is H. Moore
and I am a resident of Shelby County, Alabama; living
on the highway between Saginaw and Columbiana about
8 miles from Columbiana.

I am 83 years of age and have resided in this
area all of these years. During the last 68 years
I have known the tract of land described as:

"NW $\frac{1}{4}$ of the SW $\frac{1}{4}$; the NE $\frac{1}{4}$ of SW $\frac{1}{4}$; N $\frac{1}{2}$ of the
NW $\frac{1}{4}$ of the SE $\frac{1}{4}$; the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$; all
that part of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ south of
the Tuscaloosa Road and the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$.
All in Section 29, Township 21 Range 1 West,
Shelby County, Alabama; excepting therefrom
that part heretofore sold to H.M. Albright,
to-wit: the NW diagonal half of the SE $\frac{1}{4}$ of
NW $\frac{1}{4}$ of Section 29, Township 21 Range 1 West.
Also one strip of land being 27 feet wide
running diagonally across and off the north
west side of the SE diagonal half of the
SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 29, Township 21, Range
1 West, and making the total acreage herein
conveyed 150 acres more or less; (Known as
the Albright place)."

The first time I remember this tract it was
in possession of a Mr. Dykes. He was my neighbor.
He raised his family on this place, and later conveyed
it to a Mr. Hadaway; and Mr. Hadaway sold to the
Albrights. It was from the Albrights that a Dr. Demby,
or his wife, obtained it.

Mr. Dykes had the property fenced to keep his
stock in; and it has been under fence ever since.

At no time have I ever heard of any one
claiming any interest in the property, except those I
have named above.

After the Albrights got it I contracted to cut
the timber off of it, and I did. This was in about 1939.

I have several sons, above the age of 21 years,
who are also familiar with this tract of land and the
ownership thereof.
