That certain tract or parcel of land situated in the  $SE_{4}^{1}$  of  $SE_{4}^{1}$  of Section 32, Township 21, Range 1 West, more particularly described as follows: Begin at the southeast corner of said Section 32 and run north along the section line 660 feet; thence run in a westerly direction perpendicular to said Section line 660 feet; thence run south and parallel to said Section line 660 feet to the southern boundary line of said Section 32; thence run east along said southern boundary 660 feet to point of beginning, containing 10 acres, situated in Shelby County, Alabama.
