AFFIDAVIT

THE STATE OF INDIANA, DAVIESS COUNTY, SS:

Lulu Brown, being duly sworn on her oath, says:

That she is <u>\$0</u> years of age and has lived in Daviess County, Indiana, all her life and that her postoffice address is 500 East Walnut Street, Washington, Indiana.

That affiant knew Earl E. Mills, late of Shelby County, Alabama, during his lifetime and that she knew the next of kin of the said Earl E. Mills living at the time of his death which occurred on or about the 20th day of May, 1953.

That on said 20th day of May, 1953, the next of kin of said Earl E. Mills were the following named first cousins, to-wit:-

Cicero Eskridge whose postoffice address is 206 North East Fifth Street, Washington, Indiana, who is a son and the only living descendant of Ida Eskridge, a sister of decedent's father, William E. Mills, both of whom are now deceased, and

Greta Byler whose postoffice address is 1036 Eucalyptus Avenue, Englewood, California who is the daughter of Hugh A. Mills, a half-brother of decedent's father, William E. Mills, both of whom are now deceased.
