Embry during his lifetime and I know of my own knownledge that he held title by warranty deed, listed for taxes, paid taxes on, used, occupied, rented and notoriously hald a certain tract of land for more than twenty-five years, known as the picture show building and a lot between the picture show building and a tin garage building and a lot between the tin garage building and certain Bell property. situated in the Town of Vincent, Alabama, and across the Street from the E. E. Elorey Company. The East and West section line was the Horthern boundary line of this lot and these lots was owned by T. W. Bell or E. W. Bell or their father. The Eastern boundary line was State Highway 25. The southern boundary line was a building owned by F. A. Gorman, Sr. and by descent to Ada Gorman, his widow and Hames O. Gorman his son. The Western boundary line was the right-of-way of the Central of Georgia Railway Co. I have examined a plat executed by James L.
