The Eastern boun ary line was State Highway 25. The couthern boundary line was a builling owned by F. A. Gorman, Sr. and by descent to Ada Gorman, his widow and Mamos O. Gorman his son. The Western boundary line was the right-of-way of the Central of Georgia Mailway Co. I have examined a plat executed by James L. Bay, Jr. on the 9th day of March, 1954, an Alabama licensed surveyor #1841, whose residence was Columbiana, Alabama, and from said plat I know of my own knowledge that the boundary within said plat is a portion ne c of the real estate hereinabove described and omneddby Dr. J. C. Embry before his death for more than 25 years. Dr. J. C. Embry died testate leaving a will and naming as mo-executors J. Howard Embry and Lynda E. Florey who duly probated said will in the Office of Frobate Judge, Sholby County, Alabama, and said will devised the aboye described property including the property in the said plat to his daughters. Carleen Embry a single woman, and Lynda E. Florey being the wife of T. J. Florey, Sr. Since the death of Lr. J. C. Embry in August, 1951, Carleon Embry, a single woman, and Lynda E. Florey, the wife of T. J. Florey, Sr. have camed, listed for taxes, paid taxes on, used, occupied, rented and notoriously held the aforesaid land as described and the aforesaid lands described in said plat.
