TO THE HON. TOM C. GARNER, JUDGE OF PROBATE OF SAID COUNTY:

COME now your petitioners, The First National Bank of Birmingham, a national banking association, Robert Jemison, Jr., and Sorsby Jemison, as the executors of the Estate of Eugenia Rebecca Sorsby Jemison, deceased, who would most respectfully state and show unto the Court the following facts:

That under the terms of the last will and testament of Eugenia Rebecca Sorsby Jemison your petitioners were named and designated as executors thereof; that letters testamentary were issued to them on the 4th day of May, 1950, and that after said appointment said petitioners gave notice as required by law and that more than forty-eight months have expired since that date and the publication of said notice and that all of the debts of said decedent have been paid in full;

That under the terms of the last will and testament of Eugenia Rebecca Sorsby Jemison, deceased, John S. Jemison, Annie Jemison Woodward, Bessie Jemison Morris, Sorsby Jemison, Elbert S. Jemison, and Robert

Jemison, Jr., were named as the beneficiaries of all of the property of said decedent; that subsequent to the death of Eugenia Rebecca Sorsby Jemison on the 18th day of September, 1952, John S. Jemison, one of the beneficiaries, died and Margaret P. Jemison and John S. Jemison, Jr., were nominated and designated as the executors thereof and letters testamentary were issued to them by this Court on October 8, 1952; that in compliance with the terms of said will of Eugenia Rebecca Sorsby Jemison your petitioners as executors have received, collected and turned over to the said above named beneficiaries, strictly in accordance with the terms of the will of said decedent, all property of every kind and description bequeathed to each of them and that the same is now in their possession as the beneficiaries under said will, or in the possession of the Estate of John S. Jemison, who was a beneficiary under the will. The principal distribution of the assets of the estate was made to John S. Jemison in June of 1952 prior to his death. The trust created for . the benefit of Robert Jemison, Jr., was in June, 1952, terminated by the other five beneficiaries as permitted by the terms of said last will and testament.

PREMISES CONSIDERED, your petitioners pray that this be taken as and for their account for a final settlement of said executors, and that they be henceforth discharged as executors of said estate.
