A certain strip or parcel of land, beginning at the north boundary line of the right of way of the A.B. & C. Railroad where the west line of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 28, Township 19 South, Range 1 East, crosses said right of way and running due north 200 feet to the land now owned by H. E. Archer; thence due east 1320 feet to a point; thence south 125 feet to the north line of the A. B. & C. Railroad right of way; thence in a westwardly direction 1320 feet along said right of way to the point of beginning, being part of the S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 28, Township 19 South, Range 1 East;

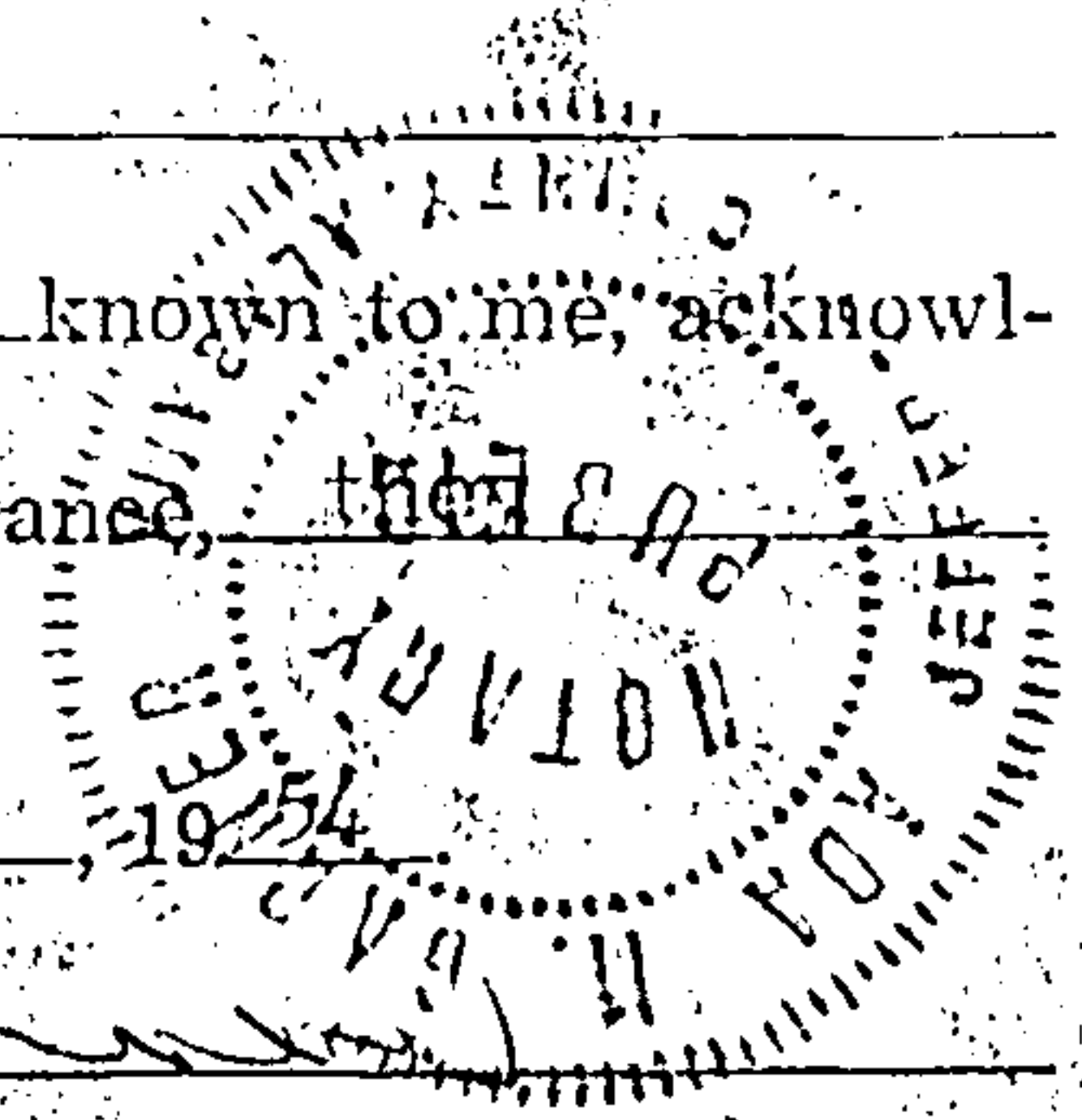
