first part, and R. J. Bruner, as party of the second part,

WITNESSETH: NOW, THEREFORE, in consideration of the
premises and the further consideration of the sum of One Dollar
in hand paid to such Trustees by the party of the second part,
the receipt whereof is hereby acknowledged, have granted, bar-
gained and sold, and by these presents do grant, bargain, sell,
and convey unto the said party of the second part the following
described property, situate, lying and being at Sterrett, in
Shelby County, Alabama, to wit:

That certain tract of land described as
commencing at the Southeast corner of the
Southwest Quarter of the Southwest Quarter
of Section 19, Township 18, Range 2 East and
run thence West along the South line of
said Southwest Quarter of the Southwest Quar-
ter of said Section 19 for a distance of 250
feet, more or less, to the East right of way
line of public highway No. 21 as the same is
now located; run thence in a Northerly direc-
tion along the Easterly right of way line
of said public highway No. 21, as now located,
for a distance of 150 feet to the point of
beginning of the lot hereinafter described
and conveyed: Run thence in a Northerly direc-
tion along the Easterly right of way line
of said highway a distance of 50 feet; run
thence in an Easterly direction to a point

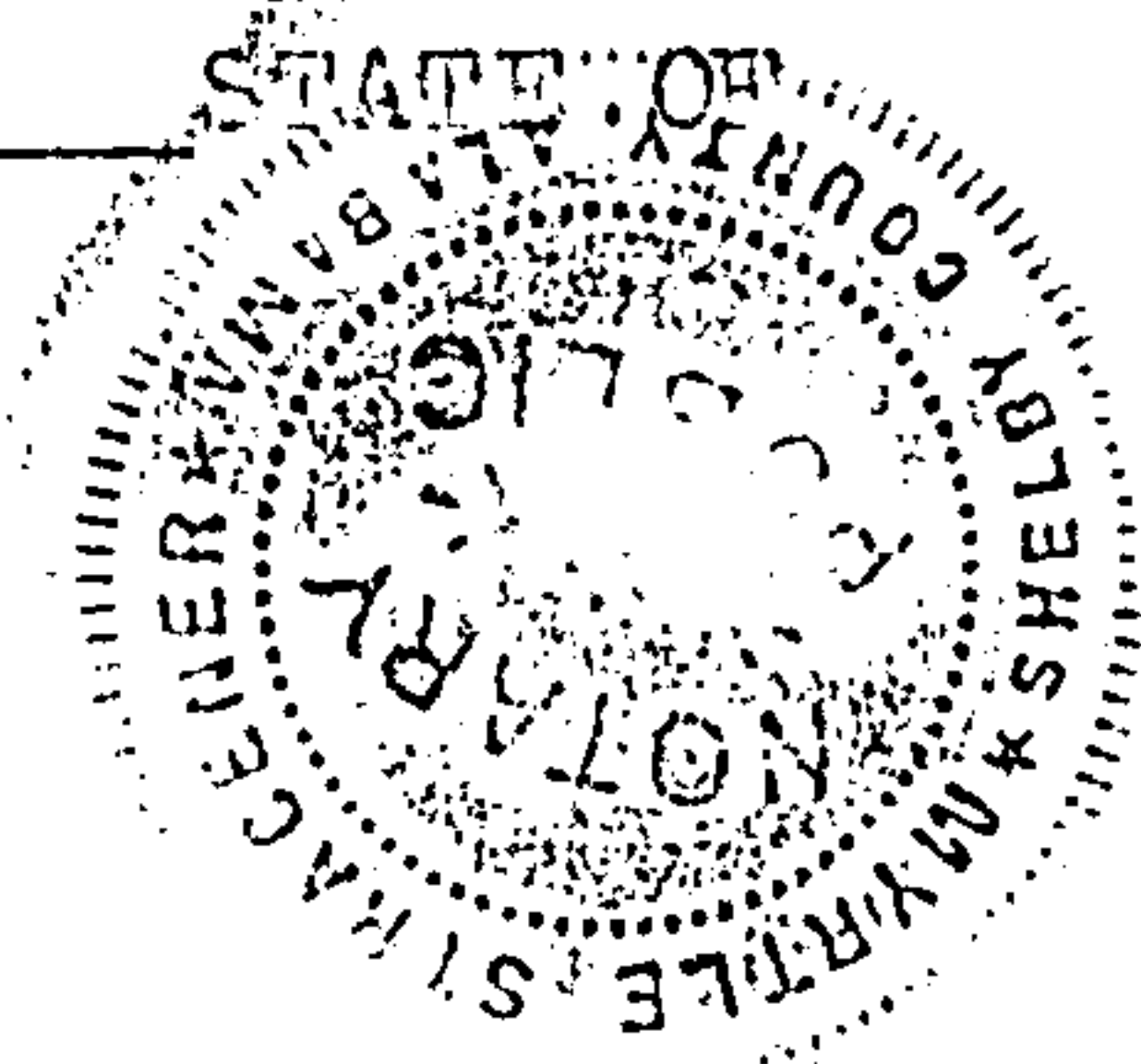
