Affiant further says that he knew said lands at the time the same was patented to James M. Wilder, and that James M. Wilder went into possession, built a house on the lands and cultivated part of the lands. Affiant further says that he remembers the ocassion when James M. Wilder exchanged this land to A. T. Robinson for other lands and that A. T. Robinson want into possession of the above desc ibed lands and lived there with his family until his death 10 or 15 Jears after he wetn into possession, and that the widow and some of the children of A. T. Robinson continued to reside on the above described premsies for some years after te death of A. T. Robinson. Affiant further says that he remembers the above described lands being sold for taxes about the year 1917 to the State of Alabama.
