Highway No. 25 at a point which is 100 feet southwest of the point where said line crosses the north line of NE¹/₄ of SE¹/₄ and run in a northeasterly direction along said right of way line 100 feet to the north line of said forty acres; thence along said forty acre line run east 190 feet; thence run in a southwesterly direction 210 feet to a point; thence run in a northwesterly direction 140 feet to the point of beginning; being situated in Section 28, Township 19, Range 2 East.

TO HAVE AND TO HOLD to the said Dillard Greene and wife, Jessie Greene, and to their heirs and assigns forever.

It being understood and agreed that this release shall not in any way impair or affect the right of the said mortgage to hold the remainder of the premises conveyed in said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid on said mortgage.
