McCall, deceased, and his wife, Sallie McCall, deceased, in hand paid by Joe Ben Myers and wife, Doshie Myers, the receipt whereof is hereby acknowledged, we, the said O.A. McCall and wife, Mary McCall, Otis W. McCall and wife, May McCall, Ocie L. McCall, an unmarried man, Vera McCall Wyatt and husband, Adam Wyatt, do grant, bargain, sell, and convey unto the said Joe Ben Myers and wife, Doshie Myers, the following described real property, situate, lying, and being in the County of Shelby, the State of Alabama, to wit:

Commencing at the Southeast corner of the Southeast Quarter of the Northwest Quarter of Section 34, Township 19, Range 2 East, and run thence West along the South line of said forty acres a distance of 226 feet, more or less, to the East right of way line of the Florida Short Route Highway and known and designated as U.S. Highway Number 91, and running thence in a Northwesterly direction along the East, or Northeast right of way line of said Highway, a distance of 1050 feet, running thence in a Northeasterly direction and perpendicular to said East right of way line of said Highway, a distance of 150 feet to the point of beginning of the lot herein described and conveyed: Continuing then in a Northeasterly direction and coinciding with the line perpendicular to the Eastern right of way line of said Highway, as aforesaid, a distance of 70 feet to a point; run thence in a Southeasterly direction and parallel with the East line of said Highway right of way a distance of 150 feet to a point; run thence in a Southwesterly direction and perpendicular to said Highway right of way line a distance of 70 feet to a point; run thence in a Northwesterly direction and parallel with the East line of said highway right of way line a distance of 150 feet to the point of beginning.
